*BACKFLOW & CROSS-CONNECTION CONTROL  
CERTIFICATION TRAINING COURSE*

**NeRWA Office, 3390 Ponderosa, Wahoo Nebraska**

**THE TRAINING:**

“Cross-Connection Control and Backflow Prevention” is designed for officials of cities and water utilities, operators and managers, building inspectors, representatives of the plumbing industry, county health sanitarians and individuals who inspect and repair backflow devices.

The 5-day course includes “hands-on” training in testing of backflow preventers with available testing equipment. Each participant will test and trouble-shoot problems using three testable devices. All classes are held in Wahoo, Nebraska

The Nebraska Department of Health and Human Services exam will be used as a final written test. Upon successful completion of this course, each attendee’s name will be submitted to the Department of Health, who will issue an application for Grade VI license, which is now required by NDHHS for testing and repairing of any testable backflow preventers.

**FEES AND REGISTRATION:**

The fee for the 5-day course is **\$500 for NeRWA members** and **\$550 for non-members**, payable to the Nebraska Rural Water Association. **If you are not a member of NeRWA, please include payment. You will not be registered until payment is received.** This fee includes all course materials and the fee charged by the NDHHS for the final exam. Your license application will be mailed to you by the Department of Health along with your test results. If you pass the test, you will complete the application and return it to the state along with payment for the license.

Pre-registration is required as the class is limited to 15.

A reminder will be sent out before the class. Anyone interested in attending should complete the accompanying registration form and return it with payment to the NeRWA office.
